02/22/13 Introductions and Apologies, Declarations Conflict of Interest, [FOIA open]

Ian Pollitt welcomed members, confirming the group was not quorate as there was a requirement to have three member representatives and three employer representatives present for any decision-making activity.

The Board accepted the meeting could go ahead as there were no specific decisions needed and looked instead to represent the Scheme Managers by holding the Scheme Administrators to account and ensuring relevant trends and risks were reported upon.

02/22/16 Training / Knowledge of Board Members [FOIA Open]

No new training subjects had been identified for members to complete and the training record tab was up to date.

02/22/20 Devon and Cornwall Police Pensions in Payment – Audit [FOIA Open]

Devon and Cornwall Police had initially been contacted by retired members who believed their pension in payment calculations were incorrect. Interest grew to an initial 50 cases, and a small project was scoped and undertaken to review records and report; this had identified some shortcomings. Accordingly, a larger cohort (overall 250 pension records) were investigated as a supplementary project and that work along with the final report had been received by Devon and Cornwall Police.

The Director of Finance for Devon and Cornwall led on a detailed verbal update and discussion ensued.

Broadly the Board were content that the review had been well managed and delivered effectively with a realistic and even-handed conclusion. NARPO were thanked for their input and collaboration throughout what had proven a lengthy process.

Due to the complexity of pension data, member records and manual interventions when calculating benefits, the Board accepted the potential for error but still found the percentage of errors found in the review concerning. Concerns were exacerbated by the fact that a high percentage of members did not access the online self-service site to check their own records were correct. McCloud Remedy would further complicate the picture for many years to come which was why the current data verification being undertaken by Forces with the pension administrators (see 02/22/19 above) was key, alongside the updated software implementation by Heywoods.
